Annual Report Highlights Capital Works Success

Council had one of it's most successful years of capital expenditure (\$42m) according to its 2023/24 Annual Report, which was adopted at Wednesday's (30 October) Council meeting.

The Report, audited by Deloitte covering from 1 July 2023 to 30 June 2024, highlighted the completion of Nukumaru Station Road extension project (Te Ranganuku Road) that opened in March 2024, the new Waimate West reservoir and the 5km Loop Track in Pātea. Te Ramanui o Ruapūtahanga, the new LibraryPlus and isite, which will be completed at the end of November, and Stage 2 of the Business Park, with roading and three waters infrastructure upgrades to Fitzgerald Lane, Little Waihi Road, Kerry Lane and SH3. The report also highlighted that the work in support of the town centre revitalisation projects for Waverley, Eltham, Öpunakē, Pātea and Manaia is progressing well. Traffic calming/pedestrian refuge measures, funded by Waka Kotahi/NZTA, had been completed along the main highway in Eltham and Waverley. Planning and design of Ōpunakē's proposed green space was completed, as well as a new pump track. Planning and design is well advanced for Eltham's Stark Park and signage and wayfinding had been implemented in Pātea. South Taranaki Mayor, Phil Nixon said the 2023/24 financial year was a challenging one, characterised by ongoing global geopolitical instability, economic volatility and a sluggish domestic economy.

'While inflation started to show signs of easing, local government inflation, for things like fuel, bitumen, electricity, construction, interest rates and insurance costs, remained high. We expect inflation and interest rates to ease further in the next 6-12 months." Despite this, the Council finished the year with a \$2.3m surplus after unbudgeted adjustments. Mayor Nixon says the main reason for this was higher than expected revenue (mainly from increased subsidies from Waka Kotahi/NZTA, South Taranaki Business Park development and financial contributions) and lower than expected direct costs due to no major severe weather events to contend with. However, because of global volatility and weak market conditions, the Council's Long Term Investment Fund made \$2.6 million less than anticipated and, after allowing for the withdrawal of the annual rates subsidy, finished the year at \$143.2 million. The Annual Report also highlighted that satisfaction with Council services remained high with 88% of residents happy with the overall service the Council provides, 96% satisfied with the facilities provided and 90% believing the Council is moving in the right direction. The services that had the lowest satisfaction rates were the condition of roads and animal management. Hāwera LibraryPlus and South Taranaki isite Visitor Information Centre will close for a short period as staff prepare to shift into the district's new library, art and information centre, Te Ramanui o Ruapūtahanga. Hāwera LibraryPlus will be closed from 5pm today (Thursday 7 November) and the isite (which includes the AA service centre) will be closed from Wednesday 20 November. Both facilities will reopen at 1pm on Monday 25 November in their new premises on the corner of High and Regent streets.

South Taranaki District Council arts and culture manager Cath Sheard encourages people to stock up on library books before the 7 November closure.

"As well as ensuring you've got enough to last you over the two weeks the LibraryPlus will be closed, it will also help us because we'll have less books to shift," says Cath. "You'll still be able to return books through the afterhours return the slot at the old library if you need to, but any books reserved for Hawera users will be held until Te Ramanui opens.

Cath also reminds people that the free Wi-Fi service will be unavailable from Thursday 7 November when the LibraryPlus closes until its reopening on Monday 25 November.
